## ABOUT THE INTERNATIONAL ARBITRATION CONFERENCE

Now in its 14th year, the International Arbitration Conference (IA Conference) is the leading event of Australian Arbitration Week (AAW).

Held annually on a rotating basis between Sydney, Melbourne, Brisbane and Perth, the IA Conference is Australia's preeminent arbitration conference, bringing together local experts and eminent speakers from around the world to discuss current and emerging issues in international arbitration.

The 2025 IA Conference included speakers from Belgium, France, Switzerland, India, Singapore, Hong Kong, the United Kingdom and the United States of America. Issues discussed included resolving disputes in disrupted supply chains, multi-party/multi-contract issues, arbitrating in new fields and preserving integrity and efficiency when arbitration participants go silent.

Over 300 delegates attended the IA Conference last year, including international law firm partners specialising in arbitration, internationally recognised and emerging arbitrators, barristers, members of the judiciary and general counsel from global organisations.

Delegates travelled from all over the world, including Austria, Belgium, France, Hong Kong, Japan, Malaysia, Papua New Guinea, Singapore, Switzerland, the Netherlands, the United Kingdom, the United States of America as well as from all over Australia.
